> Well I am now going to finish that cup of tea and wish you all a great dav.



FIRST VICE PRESIDENT

Serves as Chairman of Committees designated by the President. In the absence of the President, this Lion shall preside at the meetings of both Club and Board of Directors. Is responsible for selecting chairpersons for all projects and events.

SECOND VICE PRESIDENT

Serves as Chairman of Committees designated by the President. In the absence of the President and First Vice President, this Lion shall preside at the meetings of both Club and Board of Directors. Serves as Visitation Chairman.

THIRD VICE PRESIDENT

Serves as Chairman of Committees designated by the President. Serves as Program Chairman.

TAIL TWISTER

The Club Officer who keeps his eyes and ears open and capitalizes on all humorous situations that arise to promote harmony, fellowship, comedy and enthusiasm during the meetings. This Lion imposes and collects fines on Club Members.

LION TAMER

These officers are responsible for the Club's property. These Lions put the banners, flags and bell in their proper places before each meeting. Acts as Sergeantof-Arms. Also, is responsible for all club property used for fundraising.

MEMBERSHIP DIRECTOR
